## Terms of License Acknowledgement Carry Concealed Weapon – CCW



Sheriff's Department

The license holder understands and acknowledges the following restrictions and conditions for carrying a concealed weapon. The license holder understands and agrees that failure to abide by the restrictions and conditions outlined herein shall result in revocation of the CCW license.

- 1) In accordance with Penal Code § 26200(a), while carrying a firearm as authorized by a license issued by the Sheriff, the licensee shall not do any of the following:
  - a. Consume any alcoholic beverage or controlled substance as described in Health and Safety Code Sections 11053 to 11058, inclusive.
  - b. Be in a place, having a primary purpose of dispensing alcoholic beverages for on-site consumption.
  - c. Be under the influence of any alcoholic beverage, medication, or controlled substances as described in Health and Safety Code Sections 11053 to 11058, all inclusive.
  - d. Carry a firearm not listed in the license or a firearm for which the licensee is not the recorded owner.
  - e. Falsely represent to a person that the licensee is a peace officer.
  - f. Engage in unjustified display of a deadly weapon.
  - g. Fail to carry the license on their person.
  - h. Impede a peace officer in the conduct of their activities.
  - i. Refuse to display the license or to provide the firearm to a peace officer upon demand for purposes of inspecting the firearm.
  - j. Violate any federal, state or local criminal law.
  - k. Carry more than two firearms under the licensee's control at one time.

Pursuant to Penal Code section 26200(b), the Orange County Sheriff's Department imposes the following additional restrictions and conditions on the license holder. Failure to comply with these restrictions and conditions may result in revocation of the CCW license.

- 2) A license holder shall notify the Orange County Sheriff's Department CCW Licensing Unit of any change of address within ten days of the change. A license will expire 90 days after the licensee moves from Orange County Sheriff's Department jurisdiction if the residence was a basis for the issuance of the license, this will allow the licensee time to apply for a CCW with their new jurisdiction.
- 3) Should the license holder utilize the concealed weapon for which the license has been

issued, whether loaded or unloaded, in a rude, angry, or threatening matter or used in any fight or quarrel, the license holder shall notify the CCW Licensing Unit in writing. Written notification shall be provided to the CCW Licensing Unit within five days of the original date of incident and outline the circumstances resulting in the use of the weapon.

- 4) License holder agrees to notify the CCW Licensing Unit within five days of any arrests or when the licensee becomes the subject of any restraining order. Notifications shall be made in writing to the CCW Licensing Unit. Written Notifications shall be submitted to the CCW Licensing Unit within five days of the original date of incident. - 5) The above list is non-exhaustive and does not preclude the Sheriff or authorized designee from imposing other reasonable restrictions as to the time, place, manner, and circumstances under which the licensee may carry a concealed weapon (Penal Code § 26200(b)).
